New Government: A bold chance to tackle challenges head-on

Jordan Daily – In a recent meeting with a CEO of one of Jordan's leading consulting and strategic planning companies, it became clear that Jordan is at a pivotal moment. As the kingdom pushes forward with its economic modernization plan, backed by a multitude of global partnerships aimed at revitalizing the public sector, the numbers tell a story of progress. Jordan has seen improvements in various global indicators, particularly in business environment metrics, crime reduction, and the criminal justice system.

The CEO, who founded his firm in 2011, pointed to data that undeniably highlights the country's advancement. Over the past few years, Jordan has witnessed a marked shift in the mentality and methodoloav of both government officials and civil servants. Yet, despite these positive trends, ordinary Jordanians remain skeptical. They do not feel the tangible benefits of these reforms in their daily lives. Why is that?

In a parallel development, Prime Minister-designate Dr. Jafar Hassan visited a primary school in the remote area of Bal'ama in Mafraq, as well as a village in Deir Alla. These visits, seemingly away from the spotlight, could be an attempt to convey that Hassan is genuinely in tune with the needs of Jordan's most vulnerable citizens, far removed from political theater.

Those who have worked closely with Dr. Hassan describe him as pragmatic, politically astute, and deeply experienced in economic matters. His proximity to King Abdullah II, having previously served as the director of the King's office, has afforded him valuable insight into the King's vision for national reform. His mission is clear: revitalize the economy, raise the standard of living, and ensure justice and equality for all citizens.

However, I have reservations about some of the names in Dr. Hassan's government. While it includes prominent figures with remarkable expertise, a few individuals may not meet the expected standards. Perhaps the Prime Minister has a different perspective.

Jordan is grappling with complex geopolitical challenges—Israel's ongoing conflict with Gaza, the war in Lebanon, and Iranian missile activity in the region, not to mention the recurring violence from extremist Israeli settlers in West Bank. All of these issues demand that Jordan strengthen its internal cohesion and reinforce its social fabric.

As Hassan's government seeks parliamentary approval next month, it faces an unprecedented test. This will be the first parliament elected based on a general party list system, posing significant challenges to a government already burdened with high expectations. Whether Hassan's cabinet can earn the trust of both King Abdullah and the Jordanian people while navigating the complexities of the newly elected parliament remains to be seen.

But the question that looms larger: can this government overcome the external and internal crises it has inherited? Can it implement its executive programs with the efficiency needed to stabilize the economy and ensure sustainable growth? Jordan, a country with limited resources, finds itself disproportionately affected by the ongoing conflicts in the region. As regional wars and political upheaval persist, Jordan's ability to maintain economic resilience is under threat.

Tourism, a vital pillar of Jordan's economy, has already suffered from the region's instability. The agricultural sector, too, along with exports from both private and public enterprises, are key components of the national economy that risk further disruption. Additionally, transportation costs have skyrocketed due to challenges at Jordan's land and sea borders, placing additional strain on state revenues. As a result, the economic burden on the state is increasing, with significant implications for the social well-being of its citizens.

It is in this precarious context that Jordan's public and private sectors must come together. The only path forward is through collective action, focusing on building a resilient economy capable of weathering these external shocks. This requires moving beyond the political bickering and skepticism that often bogs down meaningful progress. The stakes for Jordan have never been higher.

Jordan is at a crossroads, and its government must prove it can steer the country through these tumultuous times. If it fails, the consequences—both economic and social—could be dire.

King meets Mikati, says Jordan stands with Lebanon



Jordan Daily – His Majesty King Abdullah II on Monday stressed that Jordan stands with Lebanon and its sovereignty, security, and stability, according to a royal court statement.

During a meeting with Lebanese caretaker Prime Minister Najib Mikati at Al Husseiniya Palace, His Majesty stressed Jordan's readiness to support the Lebanese people and mitigate the impact of the ongoing war on them.

At the meeting, attended by His Royal Highness Crown Prince Al Hussein bin Abdullah II, the King said Jordan is working in coordination with Arab and key international actors to put a stop to the Israeli war on Lebanon. The King warned that the continuation and expansion of the Israeli war on Lebanon would lead to a regional war with grave consequences.

For his part, Mikati thanked His Majesty for Jordan's support for Lebanon at all times, especially efforts to stop the Israeli war on Lebanon.

The Lebanese caretaker prime minister expressed appreciation for the relief Jordan delivers to aid those displaced by the war.

Prime Minister Jafar Hassan, Deputy Prime Minister and Foreign Minister Ayman Safadi, and Director of the Office of His Majesty Alaa Batayneh attended the meeting.



Prince Hassan calls for Mashreq region cooperation on water, energy, food, and environment

Jordan Daily – HRH Prince Hassan stressed the need for regional cooperation, proposing the creation of a regional water and energy community for Mashreq countries, modelled after the European Coal and Steel Community.

The prince's remarks came during the WEFE Nexus Conference, which was organised by the Higher Council for Science and Technology, with the support of the German International Cooperation (GIZ), and funded by the German Federal Ministry for Economic Cooperation and Development (BMZ).

German Ambassador to Jordan Bertram von Moltke and ministers of water and irrigation, environment, and energy and mineral resources attended the conference.

In his opening remarks, Prince Hassan, chairman of the Higher Council for Science and Technology, stressed the critical importance of WEFE Nexus in the Mashreq region.

He noted that this framework can foster crossborder cooperation, reduce competition over scarce resources, and promote mutual benefits.

The Prince stressed the importance of decisionmaking based on reliable data and absolute facts to ensure equitable stability and independence in the region.

He highlighted the need for integrating the WEFE nexus to serve human capital, making local communities key stakeholders in developing good governance.

"It is time for the people in our region to move from being mere followers to becoming active citizens," he said, underlining the necessity of collaboration across sectors to achieve effective governance of the WEFE Nexus.

Moltke stressed the deep interconnections between the four sectors, stressing that addressing challenges in one sector cannot be done in isolation from the others.

"If we are thinking about water, we must simultaneously consider energy, food, and the environment. These sectors rely on one another," Moltke said, adding, "You cannot pump water for agriculture or household use



without energy, and every step in this process has environmental consequences."

He highlighted the crucial role of AI in managing these complex interconnections, particularly in a country like Jordan, where water availability is critically low. "While the global average is 500 cubic metres of water per capita, Jordan struggles with only 60 cubic metres."

Mashhour Refai, secretary general of the Higher Council for Science and Technology, echoed Prince Hassan's and Moltke's sentiments, noting that Al offers powerful tools for resource management, predicting future water demand, identifying leaks, and optimising energy use within smart grids.

By analysing data across sectors, AI enhances efficiency and sustainability in ways that traditional methods cannot, he said.

He also pointed to Al's potential in revolutionising food production through precision farming, using data from sensors and advanced equipment to optimise crop management, predict weather patterns, and assess soil and plant health.

Refai said that the conference aimed to strengthen cooperation between the WEFE sectors, exchange best practices for integrated solutions, and highlight the role of AI, the Internet of Things, and renewable energy integration in achieving sustainable development.

Ibn Sina University takes major strides as Jordan's first private medical institution, says President Badran

Jordan Daily – Ibn Sina University for Medical Sciences (ISUMS), Jordan's first private medical university, has made significant strides since launching in 2022, according to the university's president, Professor Darwish Badran.

Located near Queen Alia International Airport, the university is focused on academic excellence and aligning with Jordan's royal vision of preparing a globally competitive generation.

"Our aim is to build a promising generation that recognizes the significance of the global stage amid technological, economic, and political growth," Badran told Jordan Daily, underscoring the university's commitment to staying current with developments both academically and administratively.

The university launched its Doctor of Medicine (MD) program in the 2023-2022 academic year, followed by a Doctor of Dental Surgery (DDS) program in 2023. Both programs have drawn substantial interest, with student applications exceeding the university's capacity for the 2024-2023 academic year.

"This reflects the quality of education, administrative transparency, and the genuine efforts exerted by both academic and administrative staff," Badran noted.

Ibn Sina University's modern infrastructure includes air-conditioned buildings, advanced labs for clinical skills, pathology, and microbiology, smart classrooms, a library with access to global databases, and future plans for sports facilities and recreational spaces. The facilities are designed to offer "a comfortable and safe academic experience" for students, according to Badran.

The university has secured both general and specialized accreditation for its Medicine and Dentistry programs. Badran highlighted that the institution is fully aligned with the standards set by the Accreditation and Quality Assurance Commission for Higher Education Institutions. The university's e-learning system, developed in collaboration with its IT unit, enhances communication between students and faculty.

ISUMS has established partnerships with several key institutions, including Jordan Hospital, which plays a vital role in clinical training. "Jordan Hospital will play a significant role in the clinical training of students,"



Badran said, stressing the importance of hands-on experience for students.

International collaborations with universities such as George Washington University, the University of Glasgow, and the University of Texas Health Science Center in San Antonio further support the university's ambitions. These partnerships expedite Ibn Sina's efforts to raise its academic standing locally and globally. Additionally, international faculty from these universities will assist in teaching Ibn Sina students during certain semesters.

Ibn Sina is also focused on supporting scientific research, with faculty members having published 42 research papers in international journals over the past two years, some involving student participation. The university has hosted significant events, including workshops for the Jordanian Orthopedic Surgeons Association, attended by doctors and specialists from Jordan and abroad.

The university aims to continue making progress in education, scientific research, and community engagement. "Our goal is to supply the labor market with top-quality professionals," Badran said, reinforcing the university's commitment to fostering academic growth and community partnerships.

Ibn Sina University for Medical Sciences is open to visitors at its Al-Qastal campus and is responsive to inquiries through various communication channels, Badran added.

Since its inception, more than 34,000 participants from 144 countries have benefited from various MTCP programmes.

"The MTCP is built on the principle that the development of a country relies on the quality of its human capital. The programme focuses on human resources development through training, study visits, and expert attachments," said Nasri.

He noted that since 2010, MTCP has been administered by Malaysia's Ministry of Foreign Affairs (Wisma Putra), marking a shift towards prioritising strategic partners and expanding cooperation with new development partners through publicprivate partnerships. Nasri emphasized that Jordan has been a key beneficiary of the MTCP, with over 510 Jordanian officials having participated in a wide range of training programmes covering areas such as technical and vocational education (TVET), public administration, cyber-security, and Islamic finance.

Feedback from Jordanian participants has been overwhelmingly positive, Nasri said, with many reporting that the programmes have helped them acquire essential skills for their professional and personal growth. He expressed hope that more Jordanian officials would participate in future MTCP offerings.

Nasri also called for more tailored programmes to meet Jordan's specific development needs, based on continued dialogue between the two nations.

"We hope that today's event will be the start of greater networking between Malaysia and Jordan, and a platform for fruitful collaboration in the years ahead," he concluded.

King Felipe VI in Jordan

King meets Spain monarch, stresses need to stop war on Gaza, Lebanon



Jordan Daily – His Majesty King Abdullah II, during a meeting with King Felipe VI of Spain on Sunday, called on the international community to shoulder its full responsibility in stopping the Israeli war on Gaza and Lebanon, according to a royal court statement.

During bilateral talks followed by expanded ones, attended by His Royal Highness Crown Prince Al Hussein bin Abdullah II, His Majesty stressed the importance of reaching comprehensive calm, in order to end the violence and protect the security and stability of the region and the world.

At the beginning of the expanded talks, attended by His Royal Highness Prince Feisal bin Al Hussein, the escort of honour to the Spain monarch, King Abdullah II expressed pride in the distinguished relations between the two countries, which extend over more than seven decades of close friendship and cooperation, praising Spain's leading role in strengthening the relationship between Jordan and its allies in Europe.

His Majesty said this partnership has contributed to building bridges of understanding between the region and Europe, expressing keenness to strengthen bilateral cooperation at various levels.

The King thanked Spain for its support for the National Water Conveyance Project and the Jordan Response Plan to the Syrian refugee crisis.

His Majesty praised Spain's courageous stance in supporting stability in the region and its role in dealing with regional challenges.

The talks also covered the importance of increasing humanitarian aid to Gaza and ensuring its uninterrupted delivery.

Spain's support for the two-state solution and its recognition of the State of Palestine, stressing that Jordan will continue to coordinate with Spain and the EU to restore stability in the region.

For his part, King Felipe VI of Spain highlighted the depth of the historical friendship between the two royal families and between Jordan and Spain, congratulating His Majesty on the 25th anniversary of his assumption of constitutional powers.

The Spanish monarch praised the Kingdom's reform efforts, led by King Abdullah II, expressing keenness to enhance cooperation in various sectors, especially economy, tourism and culture.

King Felipe VI stressed that the twinning between Petra and Alhambra will enrich the deep friendship between the two countries, symbolising the close ties between them.

King Abdullah II commanded He also spoke about the

challenges facing the region, expressing his country's support for Jordan in confronting them.

The talks were followed by an event attended by King Abdullah II and King Felipe VI to mark the signing of an agreement to develop a framework of cooperation and collaboration between the Petra Tourism Development Region Authority and the board of directors of the Alhambra Palace and the Generalife in Spain.

The agreement aims to exchange expertise and promote cultural initiatives that enhance knowledge of these sites and increase the number of tourists. The event included the screening of a video and featured a live musical performance.

Deputy Prime Minister and Foreign Minister Ayman Safadi, Director of the Office of His Majesty Alaa Batayneh, Jordan's Ambassador to Spain Raghad Al Saqqa, and the accompanying Spanish delegation attended the talks.

King of Spain visits UNRWA's Al-Baqa'a Girls' school



Jordan Daily – His Majesty King Felipe VI of Spain, accompanied by His Royal Highness Prince Faisal bin Al Hussein, visited Al-Baqa'a Girls' Preparatory Schools I and II, operated by the United Nations Relief and Works Agency for Palestine Refugees (UNRWA), as part of his official visit to Jordan.

During the visit, King Felipe toured the school facilities, receiving a detailed briefing on the educational and humanitarian services provided by the school. He met with the school's student parliament and several Palestinian refugees, and was informed about projects implemented by the Spanish Agency for International Development Cooperation (AECID) at the school.

Aroub Al-Mousa, Head of UNRWA's Education Program in Jordan, noted that the agency's education program supports approximately 105,000 students across 161 schools. She stressed that King Felipe's visit reflects Spain's support for UNRWA and Jordan's efforts to ensure continued services for Palestinian refugees.

Waleed Hajawi, Head of UNRWA's Northern Amman region, highlighted the importance of Jordan and Spain's leadership in maintaining international backing for UNRWA, which serves key humanitarian and educational roles in refugee camps such as Al-Baqa'a and Al-Hussein.

The visit was attended by Spanish Foreign Minister José Manuel Albares Bueno, Spanish Ambassador to Jordan Miguel de Lucas, Director-General of the Department of Palestinian Affairs Rafiq Khirfan, UNRWA Deputy Commissioner-General Antonia Marie De Meo, and Director of UNRWA Affairs in Jordan Olaf Becker.

Spanish king hails historic Madrid-Amman relations



Jordan Daily - King Felipe VI of Spain underlined the deeprooted Madrid-Amman relations in all fields.

During his meeting with the Spanish community in Jordan at the residence of the Spanish ambassador in Amman on Saturday evening, the King said, «At this moment, we are also united by a deep desire for peace and dialogue.»

«The conflict that began a year ago and brought us images of suffering and destruction in Gaza, and has further exacerbated by its extension to Lebanon, must end as soon as possible,» the visiting king said, according to the Jordan News Agency, Petra.

«We want to see an end to the humanitarian tragedy and silence the weapons, so that we can return to the path of politics and diplomacy,» he said, calling for «renewed efforts to achieve the two-state solution that lays the foundation for a lasting and enduring peace for the Palestinian and Israeli peoples.»

He expressed his happiness at the increasing presence of Spanish companies in Jordan, which contributes to promoting growth, prosperity, and employment in the Kingdom, Petra reported.

The king said that the workers in Spanish cooperation programmes have carried out distinguished work through non-governmental organisations or the cooperation office at the Spanish embassy, stressing that their work is of particular importance in light of the circumstances and challenges facing the Jordanian society, which, he said, «is familiar to receiving refugees fleeing the ravages of wars.»

Earlier on Saturday, King Felipe arrived in Amman on a two-day official visit to Jordan, during which he will meet with His Majesty King Abdullah, according to a Royal Court statement.

HRH Prince Feisal, the escort of honour, and a number of senior officials, as well as Jordan's ambassador to Spain and Spain's ambassador to Jordan were present at Queen Alia International Airport to welcome Spanish monarch, the the statement said.

Jordan signs 242\$ million investment agreement with APM Terminals to evelop Aqaba Port



Jordan Daily – Jordan has signed on Wednesday an agreement with APM Terminals, one of the world's largest port operators, for the joint development and management of Aqaba's container port, with an estimated direct investment of 242\$ million.

The signing, witnessed by Prime Minister Dr. Jafar Hassan, is expected to boost Aqaba Port's competitiveness both regionally and internationally, enhancing its capacity to attract foreign investment and solidify its role as a vital hub for trade and supply chains.

This agreement aligns with Jordan's economic modernization vision, which aims to stimulate both local and foreign investment to drive economic growth and expand job opportunities. Approved by the Cabinet last week, the project is seen as a successful example of publicprivate partnership, building on the ongoing collaboration between Aqaba Development Corporation (ADC) and APM Terminals, which has been in place since 2006.

Under the agreement, APM Terminals, a subsidiary of global shipping and logistics giant Maersk, will implement various projects, including significant infrastructure and port equipment upgrades. This will involve measures aimed at reducing carbon emissions as part of a broader initiative to achieve carbon neutrality by 2040, positioning Aqaba as one of the region's pioneering green ports. The 242\$ million investment will increase the port's capacity to more than 1.7 million TEUs, meeting Jordan's shipping needs for the next two decades, including transit trade for neighboring countries. APM Terminals will also provide enhanced access to global shipping lines, bolstering Aqaba Port's role in facilitating Jordan's exports to international markets.

The agreement includes provisions for the ADC to earn an estimated 2.5\$ billion in revenue between 2024 and 2046, in addition to taxes and broader contributions to Jordan's economy. APM Terminals has agreed to refrain from establishing competing port contracts within the region, securing Agaba Port's preferential status.

Further supporting local development, the agreement allows Aqaba Container Terminal to contribute approximately 500,000 Jordanian dinars to the Aqaba Center of Excellence. This funding will support training programs to enhance the capabilities of Jordanian personnel across various economic sectors.

The agreement was signed by Hussein Safadi, CEO of ADC, and Keith Svendsen, CEO of APM Terminals, with the attendance of Minister of Government Communication Dr. Mohammad Al-Momani, Minister of State for Economic Affairs Mohannad Shehadeh, and Chief Commissioner of the Aqaba Special Economic Zone Authority Nayef Fayez.

Jordanian SMEs expand into Saudi market through USAID-supported initiative



Jordan Daily – Sixteen small and medium enterprises (SMEs) from Jordan's service sector have successfully expanded into the Saudi market as part of the "Exporting Services to the Saudi Market" initiative, funded by USAID Business Growth Activity, with technical support from Beyond Consulting.

Bridging the gap: How Luminus is tackling Jordan's labor market mismatches

Jordan Daily – Mr. Ghazi Al-Daboubi, the Project Management Office (PMO) Director at Luminus Technical University College (LTUC), a subsidiary of the Luminus Group, outlined the critical issues confronting Jordan's business, education, and technical sectors. While acknowledging the significant hurdles, he expressed optimism about the reforms underway and highlighted initiatives aimed at bridging the gap between education and labor market demands.

In a recent interview with the Jordan Daily, Daboubi began by identifying three key challenges that have long impeded workforce development in the country: the mismatch between the skills provided by educational institutions and those sought by employers, the geographic divide between job seekers and employment opportunities, and the enduring social stigma attached to technical and service-sector jobs.

The first issue, he explained, is a "skill mismatch" that leaves many graduates ill-prepared for the demands of the labor market. "The education and training providers in Jordan are not offering the skills that businesses require," he said, underscoring the frustration among both graduates and employers who find themselves out of sync.

Equally problematic, according to Mr. Daboubi, is the geographic mismatch. Many job seekers, he noted, live in rural areas, far from where the jobs are. "Job seekers are often located in the countryside, while the available jobs are in cities, miles away from their homes," he said. This distance, combined with relatively low wages, forces workers to contend with high transportation costs or the need to relocate, which often makes employment unviable.

A more ingrained issue is what Daboubi described as the "social stigma" surrounding technical and serviceoriented jobs, particularly those that require night shifts, such as roles in the hospitality industry. "There is a cultural reluctance to accept certain types of work, like overnight shifts for female employees in hotels or technical jobs," he said. This perception, he added, "will take time to change."

Nevertheless, Daboubi pointed to the hospitality sector as an example of success. 15 years ago, less than 5 percent of workers in Jordan's five-star hotels were Jordanians, he noted. Today, that figure stands



at 95 percent. "This shift is the result of long-term awareness campaigns and efforts to change social perceptions," he said, adding that this success shows what can be achieved through persistence.

He also addressed the working conditions in Jordan's technical and business sectors, where issues such as safety, health insurance, and insufficient vacation time remain challenges. "The state has addressed some of these issues, like social security, but there is still a long way to go," he said. "However, I believe these problems can be solved with the right public policies."

At the core of Luminus's strategy, Daboubi explained, is a focus on aligning educational programs with the actual needs of the labor market. Unlike other institutions, Luminus starts by analyzing the demands of the private sector and then designs its programs accordingly. "We don't wait for students to graduate and then start looking for jobs," he said. "We begin by researching what the labor market requires and build our programs from there."

According to Daboubi, Luminus has invested significant resources in this approach. "We've spent a great deal on understanding the labor market in Jordan and the Middle East," he said, noting that LTUC's research-driven approach allows it to anticipate and meet the needs of employers.

Luminus has also forged partnerships with international organizations such as USAID, the European Union, UNICEF, and UNESCO, as well as regional entities like AI Ghurair and the Qatar Foundation. These partnerships have played a critical role in shaping Luminus's programs. "We are a businessoriented institution, but our focus is on making a social impact," Daboubi said, emphasizing the university's mission to improve lives through education and training.

He also highlighted Luminus's commitment to supporting marginalized groups, including women, youth,refugees and those living in rural areas, through specialized programs and scholarships. "We are always focused on evidence-based strategies," he said, stressing the importance of data in guiding LTUC's initiatives.

Looking ahead, Daboubi said that Luminus has ambitious plans to expand its model beyond Jordan to the wider Middle East and North Africa (MENA) region. However, he emphasized that the institution's primary focus remains on solidifying its foundation within Jordan. "We want to prove ourselves here before expanding further," he said.

Currently ,Luminus offers a range of programs, from BTEC

Technical Diplomas to boot camps in areas like media and filmmaking,coding,cyber security, cloud computing and electric,hybrid automotive maintenance.Daboubi estimated that around 75 percent of students are selffunded, with the remainder receiving support from international donors. "Our graduates are leaving here with real skills, and they are finding good jobs both locally and abroad," he said.

Among the success stories, he mentioned graduates who have gone on to work in the United States, earning competitive salaries. "Some of our graduates are making over a million dollars a year," he said. However, he emphasized that Luminus remains focused on long-term development and sustainable growth.

Daboubi concluded with a reflection on Luminus's broader mission." Our vision is to create 25000 decent and sustainable jobs for Jordanians by 2030 ," he said. "We believe in the power of education to transform lives."

Sri Lanka eyes Jordanian olive oil and Dead Sea salts in new trade push

Jordan Daily – The Chairman of Al-Salt Chamber of Commerce, Saad Bazbaz Al-Hayari, held talks on Wednesday with Sri Lankan Ambassador to Jordan, Priyangika Wijegunasekara, on strengthening commercial and investment cooperation between the two countries.

Al-Hayari, joined by the Mayor of Greater Salt Municipality, Engineer Mohammad Al-Hayari, emphasized the importance of enhancing collaborative opportunities to expand trade across various sectors.

He noted a significant increase in trade volumes between Jordan and Sri Lanka over the past two years, highlighting Jordan's primary imports from Sri Lanka, which include textiles, tea, coffee, spices, and coconut. Meanwhile, Jordan exports iron products, furniture, chemical products, and apparel to Sri Lanka.

Ambassador Wijegunasekera underscored the progress made



in Jordan-Sri Lanka relations, particularly in trade and investment.

She stressed the importance of further strengthening economic and trade ties, noting Sri Lanka's considerable cooperation in industrial sectors and labor exchange, with Sri Lankan workers employed in Jordan's industrial cities.

She expressed Sri Lanka's interest in expanding the trade volume between the two countries , pointing to a demand in the Sri Lankan market for products such as olive oil and Dead Sea salts. Wijegunasekera also confirmed Sri Lanka's willingness to facilitate Jordanian companies' entry into the Sri Lankan market.

At the conclusion of the meeting, both parties agreed to organize joint economic events aimed at bolstering commercial and cultural cooperation, as well as facilitating educational exchanges to promote shared cultural understanding.

The platform integrates three key areas: university output, labor market needs, and professional unions and associations status and requirements. "By using our platform, students gain insights into labor market demands, easing their job search post-graduation," Saleh said.

Dr. Saleh emphasized the dual pillars of education and employment as fundamental to societal development and sustainable economic growth. He noted the necessity of shifting towards vocational and technical education, challenging prevailing societal norms, and highlighting the importance of skill-building alongside academic education.

Saleh pointed out that %33 of the global economy volume consists of countries with negative population growth rates, creating job opportunities for young Jordanians. He advocated for a unified and realistic education strategy, stressing the need for financial resources to achieve desired goals. He also highlighted the importance of academic and career counseling for high school students to help them choose fields that align with future job markets and their skills, abilities, and interests.

Saleh emphasized the role of families in supporting educational institutions to elevate education standards. He noted that approximately %80 of newly created jobs are concentrated in three governorates: Amman, Irbid, and Zarqa, underscoring the need for localized development focus.

He concluded that training and employment platforms are strategic partners for universities in achieving a promising future for youth, bridging the gap between educational outcomes and the rapidly changing labor market demands.

13 Jordanian companies head to SIAL Paris to expand in European and African markets



Jordan Daily – Thirteen Jordanian food companies will participate in the SIAL Paris food industry exhibition, set to open on October 19 in Paris, according to the Jordan Exporters Association (JEA).

The participating companies specialize in a variety of food sectors, including dairy, chocolate, traditional sweets, soft drinks, confectionery, and nuts.

Ahmad Al-Khodari, the President of the JEA, emphasized in a statement on Saturday that SIAL Paris, which runs for five days, is one of the world's premier food exhibitions. "The Jordanian participation reflects the association's commitment to promoting local products and exploring new markets to boost exports," he said.

Al-Khodari noted that the JEA is focused on providing Jordanian exporters with a platform to expand their presence in European markets. "France serves as an important gateway for Jordanian industrial products to reach African markets, especially with the participation of African business figures at the exhibition," he added.

He highlighted that the event offers a significant opportunity for trade and knowledge exchange in the food manufacturing sector, with around 7,500 exhibitors representing 130 countries. "The exhibition provides a valuable chance to connect with industry stakeholders from around the globe," he said.

As part of the JEA's broader goals, Al-Khodari underscored the association's ongoing efforts to support manufacturers from various sectors by helping them access export markets through international exhibitions, seminars, and workshops. These initiatives aim to leverage trade agreements that connect Jordan to major international trade blocs.

Halim Abu Rahmeh, the JEA's Director General, expressed optimism that the Jordanian pavilion, covering 160 square meters, would yield positive results and attract the interest of buyers and importers. "SIAL Paris draws traders and importers from France, Europe, and Africa, and includes exhibitors from Egypt, Morocco, Tunisia, Algeria, Kuwait, Lebanon, and Saudi Arabia," he noted.

Abu Rahmeh emphasized the JEA's commitment to finding new and non-traditional markets for Jordanian products through participation in specialized exhibitions that promote industrial goods and facilitate business deals.

"Diversifying export markets is vital for local industries," he stated, "and we always look for opportunities to take part in international exhibitions that can bolster the visibility of Jordanian products."

Mobedco showcases robust H2024 1 performance, sets stage for future growth



Jordan Daily – In a remarkable display of resilience and strategic prowess, the Arab Pesticides & Veterinary Drugs Manufacturing Co. (Mobedco) has reported impressive financial results for the first half of 2024.

The company's financial statements for the period ending June 2024, 30, underscore significant growth across key financial metrics, signaling a robust outlook for the remainder of the year.

Mobedco's total assets surged to JOD 52.13 million, a notable increase from JOD 48.15 million as of December 2023 ,31. This upward trajectory is driven by strategic investments in non-current assets, which climbed to JOD 12.20 million from JOD 10.79 million. Investments in property, plant, and equipment were particularly strong, rising to JOD 8.40 million from JOD 7.63 million, while projects under construction saw an uptick to JOD 3.02 million from JOD 2.44 million.

On the current assets front, Mobedco's figures rose to JOD 39.94 million from JOD 37.36 million, with accounts receivable reaching JOD 14.95 million, up from JOD 13.74 million. This growth is complemented by an increase in cash and cash equivalents, which expanded to JOD 5.39 million from JOD 4.48 million.

Shareholders' equity has also seen a commendable rise, improving to JOD 33.78 million from JOD 32.56 million. This growth is underpinned by an increase

in retained earnings, which rose to JOD 12.63 million from JOD 11.32 million. Including non-controlling interests, total equity reached JOD 41.88 million, up from JOD 40.00 million.

The income statement highlights the company's strong operational performance. Net sales increased to JOD 16.30 million, up from JOD 15.05 million in the same period of 2023, demonstrating robust demand for the company's products. Gross profit rose to JOD 5.73 million from JOD 4.90 million, indicating improved operational efficiency and cost management. Net profit saw a commendable rise to JOD 3.73 million, up from JOD 3.29 million, attributable to enhanced cost management and higher sales.

Earnings per share also reflected this positive trend, with basic and diluted earnings per share attributable to shareholders at JOD 0.179, compared to JOD 0.174 in the same period last year.

Mobedco's performance reflects not just its resilience in a challenging market environment but also its strategic acumen in navigating complexities and seizing growth opportunities.

Established in 1991 and listed on the Amman Stock Exchange, Mobedco has carved a niche for itself in the production of pesticides and veterinary medicines, contributing significantly to agricultural productivity and animal health.

Agriculture saves Jordan JD 800 million, livestock exports surge %260



Jordan Daily–Minister of Agriculture, Khaled Hneifat, stated that the agricultural sector's continued growth in the second quarter was driven by the implementation of the Economic Modernization Program and the National Plan for Sustainable Agriculture. These initiatives have positively impacted the sector through the integration of production inputs, a reduction in imports, and an increase in exports.

Hneifat highlighted that the agricultural sector helped save up to JD 800 million by reducing imports of fruits and vegetables while boosting agricultural exports. He also noted a significant rise in livestock exports, which surged by over %260.

According to a quarterly report by the Department of Statistics, preliminary estimates show that most economic sectors experienced growth in the second quarter of 2024 compared to the same period in 2023.

The report revealed that agriculture recorded the highest growth rate during this period, with a %6.2 increase, contributing 0.24 percentage points to the overall growth rate.

Raising minimum wage in Jordan: A necessity

Jordan Daily – In the midst of our region's volatile political climate, as the Israeli occupying state intensifies its aggressive expansionism and tensions escalate to unprecedented heights, discussing economic issues like raising the minimum wage may seem like a luxury, far removed from our top-of-mind priorities. Yet by ignoring economic dimensions during crises, we weaken our ability to confront the challenges we face on social, economic, and political levels.

Implementing a minimum wage policy provides both individuals and families with income necessary to meet basic needs. Such a policy is considered one of the cornerstones of countries aiming to achieve social balance, reduce poverty, and enhance social protection – with more than %90 of countries worldwide applying a minimum wage policy in various ways.

The minimum wage is defined as the lowest level of pay that a worker should receive to cover their essential needs and ensure a dignified life for themselves and their families, especially for newcomers to the labor market and those with limited skills. However, in many sectors of the Jordanian economy, the minimum wage is treated as the maximum wage. When the minimum wage is treated as a cap, its fundamental role in enabling progress towards social justice is undermined.

Looking at international experiences, we find that raising the minimum wage is often based on an analysis of social and economic criteria that include the poverty line, dependency ratios, and inflation levels. In Jordan, the poverty line calculated using 2016 figures shows that the monthly poverty threshold for an individual is approximately 100 dinars, meaning that the minimum required to cover the needs of a standard family (comprising 4.8 members) should reach around 480 dinars monthly. Further, since 2016, Jordan has witnessed an accumulated inflation rate of about %20, indicating a significant increase in the poverty line.

Based on these indicators, the current minimum wage of 260 dinars is clearly far from covering the basic needs of families. In this context, the Jordanian Trade Union Confederation calls for raising the minimum wage to 300 dinars per month. However, while important, this demand still remains insufficient



to address the current economic challenges facing families today.

Some oppose a minimum wage policy despite its social welfare importance, arguing that such policies negatively impact unemployment rates and economic growth. Applied economic research describes varying outcomes in response to this claim. In many countries, no negative effects were observed, although in some limited cases, raising the minimum wage has led to a slight decrease in employment rates among less-skilled groups. On the other hand, studies have shown that increasing the minimum wage often boosts domestic consumption demand, which is the engine for fueling economic growth, increasing job opportunities, and thereby stimulating the economy.

Raising the minimum wage is not merely an economic issue, as some business leaders might view it; rather, it is a social and economic necessity. A minimum wage is critical to ensuring a minimum level of social justice, reducing economic inequality, and stimulating the economy. Given the current challenges facing society, it is essential to adopt economic policies that contribute to maintaining stability in Jordan, as well as stimulate domestic consumption to break free from the cycle of economic stagnation we have been experiencing for the past 15 years, and finally, to ensure a decent life for citizens.

Taiwan celebrates National Day, highlights strategic, and economic ties with Jordan



Jordan Daily – Taiwan celebrated on Wednesday its National Day with a reception hosted by the Taipei Economic and Cultural Office in Jordan, where Representative Ali Yang underscored Taiwan's strategic role in global trade, economic success, and its growing partnership with Jordan.

In his remarks, Yang outlined Taiwan's economic accomplishments, citing the country's role in the global supply chain. Taiwan ranks 19th in the world for trade volume, with a Gross National Product that is 22nd globally.

He noted that Taiwan produces over %60 of the world's semiconductors and %90 of its high-end chips, supporting the international technology sector. In 2023, Taiwan's trade volume reached 784.4\$ billion, and by year-end, Taiwanese investments abroad amounted to 455.8\$ billion, largely driven by high-tech industries. Taiwan is ranked as the eighth most competitive economy globally, according to the Global Competitiveness Yearbook 2024 published by the Swiss-based IMD.

Yang highlighted Taiwan's strategic importance, particularly the Taiwan Strait—a key route for global trade where %50 of the world's container shipping passes and over 1.5 million flights cross annually. "Maintaining peace and stability in the Taiwan Strait is essential for global trade," Yang noted. Taiwan has taken steps to bolster its defense capabilities and strengthen partnerships with countries that value peace, he added.

Despite the absence of formal diplomatic relations, Taiwan and Jordan enjoy a strong, cooperative relationship, Yang said. Taiwan is one of Jordan's largest investors, with eight textile factories providing 7,000 jobs and contributing %6 to Jordan's annual exports. Bilateral trade reached 380\$ million last year, with Taiwan sourcing essential minerals from Jordan, such as phosphorus and potassium fertilizers.

Yang also praised Jordan's humanitarian efforts in hosting millions of refugees from conflict zones, acknowledging the country's contributions to regional stability. Taiwan has partnered with Jordan to provide aid for thousands of refugees and local families, collaborating with various Jordanian government bodies and non-governmental organizations.



"Taiwan and Jordan play crucial roles in maintaining stability in the Far East and the Middle East, respectively," Yang said. "We share values of peace, human rights, and the rule of law." He expressed hopes for continued collaboration between the two countries amid global challenges.

The evening reception featured Taiwanese delicacies, tea, coffee, and a virtual reality experience by HTC, offering guests a taste of Taiwanese innovation and culture.

Korean Ambassador calls for unity in pursuit of peace at National Day reception



Jordan Daily – The Republic of Korea's Ambassador to Jordan, Pilwoo Kim, called for a united global effort to promote peace and humanity, during a reception held on Wednesday to mark Korea's National Day.

The event, which took place a day ahead of Korea's National Day on October 3, celebrated ""Gae-Cheon-Jeol"" or "the day the heavens opened," marking the founding of the first Korean kingdom in 2,333 BC, more than 4,000 years ago.

"Four millennia is a vast stretch of time," Kim said, "but the true essence lies in the vision of our founding fathers: to broadly benefit the world and help others." He highlighted the principles instilled by Korea's forefathers, who emphasized living not just for oneself or one's own nation, but for the well-being of all humanity.

These values, Kim added during the reception attended by the Minister State for Foreign Affairs Nancy Namrouqa , ambassadors, and public figures, have guided Korea's foreign policy, which remains rooted in commitments to democracy, human rights, a rules-based international order, multilateralism, and mutual respect.

The Ambassador praised Jordan for its humanitarian efforts in hosting millions of refugees from neighboring countries, describing the Kingdom as a stabilizing force in the region. "We deeply appreciate this vital role of Jordan," he said, noting the shared values between the two countries, particularly their mutual respect for culture, tradition, and human dignity.

Marking six decades of bilateral relations, the ambassador underscored Korea's role as one of Jordan's key partners in development, particularly in water resources management and vocational training.

Acknowledging the turmoil in the region, Kim emphasized the importance of collective global efforts for peace. "We do not take this celebration for granted," he said, referring to ongoing conflicts in the Middle East, including fresh violence witnessed the previous evening.

He concluded by encouraging attendees to reflect on the need for a safer, more secure world—a vision, he said, that Korea's founders had foreseen 4,000 years ago.



Ambassador Chuandong highlights China's global leadership and economic growth



Jordan Daily – Chinese Ambassador to Jordan Chen Chuandong marked the 75th anniversary of the founding of the People's Republic of China at a reception Wednesday in Amman, underscoring China's global milestones and the expanding partnership with Jordan.

In his remarks , Ambassador Chuandong reflected on China's rapid transformation over the past 75 years. He cited the country's significant economic growth, noting its share of the global economy increased from %1.7 in 1978 to approximately %17 in 2023. He also pointed out China's leadership in areas such as space exploration, quantum information science, and renewable energy technology.

"China has become a world leader in manned spaceflight, lunar exploration, quantum information science, and new energy technology," Chuandong said. He added that China's high-speed rail network is the largest in the world, and over %60 of the world's 5G base stations are located in China.

He underscored China's efforts in poverty alleviation, mentioning that nearly 800 million people in rural areas have been lifted out of poverty over the past 75 years. He also noted China's role as a major trading partner for over 140 countries, as well as its contributions to global development through initiatives like the Belt and Road Initiative, which Jordan has joined.

Chuandong praised Jordan's role in addressing regional conflicts, particularly the ongoing crisis in Gaza. "From the outset, China has firmly pushed for ceasefire, upheld international justice, and provided humanitarian aid," he said, lauding Jordan's humanitarian efforts under the leadership of King Abdullah II. reign, the ambassador congratulated Jordan on its progress in nation-building and modernization. He expressed confidence that China and Jordan would continue to strengthen their partnership in the years to come.

Bilateral ties between China and Jordan have grown steadily since the establishment of diplomatic relations in 1977. In 2024, the two countries have seen an expansion in high-level exchanges and economic cooperation. A Chinese company recently began production at a new garment factory in Aqaba, while another is partnering with the Aqaba Special Economic Zone Authority to develop an industrial park with an expected investment of over 1\$ billion. China has also entered into a green hydrogen production partnership with Jordan.

In addition to economic collaboration, Chuandong highlighted cultural and educational exchanges between the two countries. More than 500 Chinese students are currently studying in Jordan, and Chinese cultural events, including performances at the Jerash Festival, have been well-received.

Concluding his remarks, Chuandong introduced several Jordanian students and young people in attendance who had received Chinese Ambassador Scholarships. He expressed gratitude to organizations that have supported China-Jordan relations, including the Jordanian-Chinese Friendship Association and the Jordan-China Cultural Cooperation Committee.

Ambassador Chuandong ended by wishing continued prosperity for China and lasting friendship between China and Jordan.

Bulgarian Embassy marks National Day

Jordan Daily – Jordan welcomed around 4.7 million tourists in the first nine months of this year, according to the latest statistical bulletin from the Ministry of Tourism and Antiquities.

The bulletin indicated that approximately 4.021 million of these visitors were overnight tourists, while about 680,723 visited for a single day.

Tourism revenue for the first eight months of the year reached 4.951\$ billion, equivalent to around 3.515 billion Jordanian dinars, the bulletin noted.

"We envision every governorate becoming a hub of growth, not just Amman."

Jordan Strategy Forum calls for reassessment of special taxes on electric vehicles



Jordan Daily – In light of the increasing adoption of electric vehicles (EVs) and their significant impact on transportation and environmental sustainability, the Jordan Strategy Forum urges the government to reconsider its recent decision to impose special taxes on electric vehicles. This move comes amidst a backdrop of rising fuel efficiency and declining public revenues from fuel taxes, which are traditionally used to finance vital infrastructure and public services.

As global sales of electric vehicles soar—from 7,000 battery electric cars in 2010 to 9.5 million in 2023—the demand for sustainable transportation options continues to grow. In Jordan, over %45 of vehicle sales are now electric, positioning the country as a regional leader in EV adoption. However, the newly imposed special taxes, particularly on affordable electric vehicles priced between JD 10,000 and JD 25,000, disproportionately affect middle-income households.

The Forum emphasizes that instead of increasing taxes on electric vehicles, the government should explore alternative revenue-generating measures, such as a moderate increase in vehicle registration fees across all categories. This approach would provide a steady income stream while supporting the transition to cleaner energy sources, ensuring that Jordan keeps pace with global trends in sustainable transportation.

As the Kingdom moves toward a greener future, it is crucial to strike a balance between necessary public funding and the promotion of environmentally friendly technologies. The Jordan Strategy Forum advocates for policies that foster the continued growth of the electric vehicle market, benefiting both the economy and the environment.

Background

Electric vehicles are one of the most significant technological advancements of the modern era. With growing environmental awareness and a heightened focus on sustainability, their adoption has surged significantly in recent years. Continuous technological innovations, supportive government policies, and the increasing emphasis on reducing carbon emissions have all played pivotal roles in encouraging individuals to choose electric vehicles as a more environmentally friendly and efficient means of transportation.

With the increasing use of electric vehicles (batterypowered and plug-in hybrids), fuel demand has fallen to unprecedented levels, leading to lower public revenues resulting from fuel taxes. This alternative is effectively reducing public revenue WHICH is typically used by many countries in the world to finance transport infrastructure, highways, as well as other items of public expenditure.

Key Observations on Electric Vehicles

Based on the International Energy Agency's (IEA) database, it is worth noting the following observations about the use of electric vehicles globally, regionally, and locally.

A. Global sales of battery electric cars have increased from 7,000 in 2010 to 9.5 million in 2023.

B. Global sales of plug-in hybrid cars have increased from 450 in 2010 to 4.3 million in 2023.

In 2023, electric vehicles account for approximately %18 of global vehicle sales. Notably, this share reached %93 in Norway, %60 in Sweden, %38 in China, and %24 in Germany.

Jordan led the Middle East in electric vehicle sales, with over %45 of all vehicles sold being electric. The UAE ranked second in the region, with a sales share of %13.

The growing shift toward electric vehicles in many countries has been fueled by various "tax benefits" and incentives, such as tax exemptions, reduced taxes on electric vehicles, and lower registration fees.

Despite their many advantages, while electric vehicles still contribute to the wear and tear of streets, highways, and bridges, they do not generate fuel tax revenue like traditional vehicles do. Naturally, this simple fact raises the question: How will road infrastructure and other public spending be financed if revenues from fuel taxes decline?

Many countries are exploring various options to compensate for the revenue shortfall caused by reduced fuel consumption. These include increasing fuel tax rates, raising vehicle registration fees—particularly for electric vehicles—transitioning from fuel taxes to road usage fees (based on mileage traveled), and introducing taxes on the electricity used to charge electric vehicles.

On September 17th, 2024, the Jordanian government made sudden amendments to the special tax regulations, including a reduction in the special tax on gasoline vehicles from %67 to %60, and the imposition of a special tax on electric vehicles. This tax is set at %40 tax for electric vehicles whose price is between JD 10,000 and JD 25,000 JOD, and at %55 tax for those whose price is above JD 25,000.

Relative to the above-mentioned observations, is useful to note that the total number of registered vehicles in Jordan has risen from around 1.6 million in 2018 to approximately 2 million in 2022. Naturally, this number is expected to increase further in 2023 and 2024. Indeed, the increases in the number of registered vehicles is driven by



several factors, including population growth, inadequate public transport system, and the rising demand for more affordable electric vehicles compared to fuel-based alternatives.

Jordan Strategy Forum Recommendations

Given the economic and environmental benefits of electric vehicles (EVs), the Jordan Strategy Forum emphasizes the need to reconsider the government's recent decision to impose special taxes on EVs. Instead, the government should explore alternative measures to offset the decline in its revenues, especially since the tax increase disproportionately affects EVs priced between JD 10,000 and JD 25,000—a segment most suitable for Jordanian households (typically consisting of 4.8 members), and those with middle incomes.

One viable alternative is a moderate and carefully planned increase in vehicle registration fees across all categories. This approach would indeed help compensate for the reduced fuel tax revenues by generating consistent annual income, while maintaining Jordan's progress towards clean energy adoption. This would also ensure that the country's transition to cleaner energy sources continues at a pace comparable to other nations in the region and aligned with global trends. Kuwaiti royal family member arrested on drug charges
